16. Nature-Based outdoor classroom – Flamstead School – The Parish Council agreed to match funds raised by the school up to the value of £4500.00, this is to be further discussed due to Grant policy regarding grants – the matter has been discussed via the clerk with HAPTC.
17. Pavilion Security – The pavilion has been identified as remote and vulnerable – Pavilion committee to be set up (Cllr Humphreys, Cllr Williams and Cllr Russell) – to improve security at The Pavilion.
